

REPRESENTATION

Local Unions shall be entitled to representation on the following basis:

- A Local Union with one hundred (100) members may send one (1) delegate and one (1) additional delegate for each additional one hundred (100) members or majority fraction thereof:

EXAMPLE

- (a) A Local Union with one hundred (100) members may send one (1) delegate.
 - (b) A Local Union with less than one hundred (100) members may send one (1) delegate.
 - (c) A Local Union with one hundred fifty (150) members may send two (2) delegates.
 - (d) A Local Union with one thousand (1000) members may send ten (10) delegates, and so on, with one additional delegate for each additional one-hundred (100) members or majority fraction thereof.
- A Local Union shall be represented on the basis of its average paid and exonerated membership. Such membership shall be based upon the per capita records.

VOTES

- On voice vote, each delegate will be entitled to one (1) vote.
- On roll call vote, the voting strength for each Local Union shall be one (1) vote per member.
- The Credentials Committee shall be authorized to compute the voting strength of each Local as set forth above.

DELEGATES

- Delegates shall be selected at an official meeting of the Local Union.
- Only bonafide members in good standing and who are employed in or around the plants in the Local's jurisdiction and employees of the United Steelworkers (USW) shall be entitled to act as delegates.
- No delegate shall be seated who does not qualify under Article III, Section 3 of the International Constitution.

CREDENTIALS

- The enclosed credential forms shall be executed as soon as delegates are selected.
- The Recording Secretary of each Local shall on or before **July 12, 2019** send one credential (original copy) for each delegate to:

- Each credential shall be filled out in duplicate and impressed with the Local Union seal, the original to be mailed as directed above and the delegate shall present the duplicate to the Credentials Committee at the Conference. **If your local union does not have a seal, please indicate by checking box on the credential.**

RESOLUTIONS

- Resolutions may be presented to the Conference on any subject proper for consideration by the Body and not in conflict with the Constitution of the United Steelworkers (USW).
- Each Resolution shall deal with only one subject and shall be typewritten on only one side of the paper.
- Resolution shall be mailed to Ruben Garza, Director, District 13 not later than **July 12, 2019**.

Note: Each Local shall pay all costs, including transportation to and from the Conference, of its delegates while in attendance at the Conference.

There shall be an Early Registration Fee of \$200.00 for registrations submitted by July 12, 2019. For registrations submitted after July 12, 2019, the Registration Fee shall be \$250.00. The Registration Fee for each delegate will include one banquet ticket. Guest banquet tickets are \$75.00 each. Registration Fees must be sent WITH the original credential before July 12, 2019.
