

## 2024 United Steelworkers Health, Safety and Environment Conference

## Greetings:

We are pleased to announce that the 2024 USW Health, Safety and Environment Conference will convene on Monday, August 19 at the David L. Lawrence Convention Center and Westin Hotel in Pittsburgh, PA. This invitation should be extended to health, safety and environment activists, local union leadership and if you choose your management colleagues, but your employer cannot send more management members than union members.

A union-only session will be held on Monday, August 19; the union-management session will be Tuesday, August 20 through Friday, August 23, 2024.

Online registration is open Monday, February 12, 2024 and will close Wednesday, July 31, 2024. Participants are urged to pre-register online and can do so by going to <a href="https://www.usw.org/hseconference">www.usw.org/hseconference</a>. There will be an early-bird registration fee of \$400, which will be available from February 12, 2024 to April 12, 2024, after which the registration fee will increase to \$450.

To take advantage of the early-bird registration fee, all balances must be paid in full by April 12, 2024. If there is a remaining account balance after April 12, 2024, the registration fee will change to the normal fee of \$450.
